Closing Date: Entries will be accepted until 5:00 PM on Thursday, February 5, 2009, after which time entries will not be accepted, canceled, altered or substituted. All entries must be delivered to Penny Larson, 2119 Beckenham Way, Roseville, CA 95747. Overnight and express mail entries **MUST** specify **NO SIGNATURE REQUIRED**.

Entry Fee: \$45.00 payable in US dollars. A \$.50 AKC recording fee and \$1.50 event fee is included in each entry and will be forwarded to the AKC per CH 11, Sec. 2 of the AKC Rules and Regulations. Make checks payable to TRACS.

Certification: Each entry for a dog that has not previously passed an AKC Tracking Dog Test must be accompanied by a written statement, dated within one year of the date of the test, signed by a person approved by AKC to judge tracking tests, and must certify that the dog has satisfactorily performed a certification test. Certifications will be returned to entrants who do not run their dogs in this test.

Tracking Test Entries: Dogs holding the title of Tracking Dog shall not be barred from competition; however, dogs not having a TD will be given preference by the Test Secretary. Entries are limited to 12 dogs.

The Draw: A random drawing of all entries received by the closing date and time to determine which entries will participate in the test will take place on Thursday, February 5, 2009 at 5:30 PM at Jack in the Box, 8655 Auburn Blvd., Roseville, CA.

Alternate List: An alternate list will be maintained and will consist of entries received by the closing date but not pulled in the initial draw. Drawing for the alternate list will immediately follow the drawing for entries which are to run.

Notification: Notification of the draw results will be made as soon as possible after entries have closed. Should such notification not be received by the exhibitor within a reasonable time, please contact the Test Secretary.

Refund Policy: The entry fee shall be refunded to any entrant if the secretary is notified prior to the draw of such withdrawal and an alternate is available to run the track and for all alternates not given the opportunity to run a track.

Bitches in season may participate: If you know that your bitch will be in season the day of the test, notify the test secretary ahead of time. When you arrive at the test site, park your vehicle away from the other cars and notify the test secretary that your entered bitch is in season. The last track to be laid will be reserved for the bitch in season. If there is more than one bitch in season, a second draw for those bitches will be held. Bitches in season will only be allowed to participate after all other dogs and bitches not in season have been tested. They must be kept away from the rest of the entered dogs. Failure to comply will result in the handler and dog being excused from the test site and any award withheld.

Draw for running order: All entrants must be at the test site by 7:00 AM the morning of the test, at which time there will be a draw for running order. Entrants not present at that time will be marked absent and an alternate will be allowed to run in their place.

Judging will begin as soon as tracks have sufficiently aged.

Awards: A dark green qualifying ribbon and a rosette will be awarded to each passing dog.

Dogs on leash: All dogs and bitches entered in this test must be kept on leash at all times. Failure to comply will result in the dog and handler being excused from the test site and any awards earned will be withheld. This also applies to any non-entered dogs that may accompany anyone to the test.

Directions to test site: From Sacramento take Hwy 50 east towards Placerville. Take Sunrise Blvd. South exit and go 4 miles to Douglas Rd. Turn right on Douglas Rd. and go 1 mile to Eagles Nest Rd. Turn left on Eagles Nest Rd. Go 2/10 mile and turn left into Mather Field Rotary Park where we will meet for the draw. **From Placerville** take Hwy 50 west towards Sacramento and follow the above directions.

Practicing is allowed in the fields. The areas we are allowed to use are anything on the right after you turn onto Eagles Nest Rd. all the way to Woodring Rd. and anything on the left past the golf course. Please do not use the area on the right beyond Woodring Rd. as dogs are no longer allowed in that area.

Exhibitors should follow their veterinarian's recommendation to insure their dogs are free of internal and external parasites and communicable diseases and have appropriate vaccinations. Rabies vaccine is required in the State of California. Do not leave any dogs in closed vehicles. If any dog is seen to be suffering from extreme temperatures or is confined without supervision, the authorities will be notified to handle the situation. Violators may be reported to the Test Committee for disciplinary action. All persons attending this test hereby waive any claim for damages against TRACS or its members in the event a motor vehicle must be entered to rescue a dog from over-heating or suffocation due to improper ventilation.

Parking: The parking lot requires a daily use fee of \$5.00 per car per day.

This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such injuries, death or damage to property may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons. INSTRUCTIONS

- (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., Over 13 in. But not exceeding 15 in.), Dachshunds (long-haired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to AKC. (For complete rules, refer to Chapter 11, Section 3.)
